## New Member's Shooting Card

It is compulsory for a new applicant for membership to shoot a minimum of 2 x round of 25 targets under supervision of the Club Captain or a Management Committee Member or a Senior/Veteran Member of the Club nominated for this purpose. The shooting ticket(s) to be attached to the card. All prospective applicants are allowed to shoot 4 x rounds of 25 targets at member's rates prior to submitting his/her application for membership. After submitting his/her application form with the proof of payment of the membership fees in advance, applicants shall enjoy temporary member's privileges pending their application being accepted or rejected by the Management Committee. If an application is rejected by the Management Committee, the applicant shall forfeit 50% of the registration fee, but receive a full refund of the remaining fees paid in advance, whereupon his or her temporary member's privileges shall lapse.

**MEMBER'S AND VISITOR'S INDEMNITY FORM**

1. Shooting ranges by their very nature are potentially hazardous and involve the risk of serious injury and/or death and/or loss or damage of property;
2. I am aware of the severe and/or fatal risks, dangers and hazards associated with my participation in any clay target shooting activities and/or mere presence on the premises;
3. I hereby waive any and all claims that I have or may have against VGC and/or the Managing Committee of the club or its officers, club captain, manager, employees, officials, nominated instructors and/or contractors and to Release and Indemnify and hold VGC and its Managing Committee, club captain, officers, manager, officials, employees, nominated instructors, contractors and agents harmless from any and all liability for any loss, damage, injury, death or expense that I or my next of kin or any third party may suffer as a result of any cause whatsoever, even if such claims, damages, expenses, causes of action or liability result partially or wholly from any negligent act or acts or omission to act by VGC or its Management Committee, club captain, officers, manager, employees, officials, nominated instructors, contractors and/or agents;
4. I enter into this Indemnity and Waiver willingly and understand that by me signing this Form, I release all claims against VGC and its Management Committee, club captain, officers, manager, employees, officials, nominated instructors, contractors and/or agents and assume all risk inherent in attending a gun shooting range where live ammunition is shot; and
5. I have read, understand and accept the Safety, Etiquette and By-Laws of VGC as published on the club's website and/or displayed on the wall outside the club house and undertake to adhere thereto at all times.
